VISION 2026

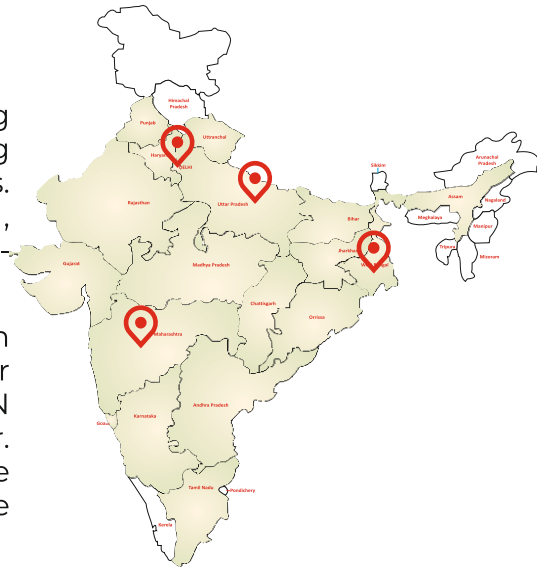
Vision 2026 – “Vision 2026” is an ambitious plan to bring about transformation on the social landscape of the country. The plan envisages the establishment of multifarious institutions across the country, with a strong human resource of committed volunteers and recognized community leaders. The program intervenes the needs of the day when one-thirds of country’s population hardly met the basic amenities for its servility.



BRIEF BACKGROUND OF PROJECT EHSAS

In 2021, Vision 2026 launched 'Project Ehsas' by establishing community kitchens in Kolkata and Delhi, aimed at supporting migrant workers and slum dwellers struggling to afford essentials. This initiative provides Cooked Meals to the underprivileged, addressing the severe hunger crisis worsened as a result of the Covid-19 lockdowns and subsequent job losses in India.

In 2022, we expanded our efforts by opening additional kitchens in Mumbai and Lucknow. With plans to set up more kitchens in other cities, we remain committed to our mission, which aligns with the UN Sustainable Development Goals of No Poverty and Zero Hunger. Recognizing hunger as a global pandemic that requires collective action, we rely on your generous support to transform this noble initiative into a widespread movement for a hunger-free India.



WHY THIS PROJECT?

- The 2024 Global Hunger Index ranks India 105th among 127 countries. The Index also highlights food insecurity as a pressing issue. Rising food prices due to inflation and post-pandemic disruptions have further reduced access to affordable, nutritious food for low-income families.
- According to the National Family Health Survey (NFHS) of 2019-21, in urban Delhi, approximately 64% of children under five are now anaemic. Further, there are **approximately 100,000** homeless people living in India's capital, with a significant proportion being children.
- With 35.5% of children stunted (short for their age) and 19.3% wasted (underweight for their height) as of 2020-21, malnutrition is a severe issue in India. Further, the economic fallout from Covid-19, which caused widespread unemployment, has left many families across the country struggling to afford basic meals.



IMPACT

With the generous support of our donors, we have provided over **3,50,000** freshly-cooked meals to slum dwellers, offering critical nourishment to the most vulnerable.
